Dear Sir / Madam,

With reference to your application dated 26th March 2021 and subsequent correspondence with the school, I convey the grant for provisional recognition to **DAV Public School NTPC Township, Jamthal, P.O. Jamthal, Tehsil Sadar, Distt Bilaspur (H.P)** for class 6th to 8th for period of Five years w.e.f. 01-04-2021 to 31-03-2026.

The above sanction is subject to fulfilment of following conditions:-

1. The grant for recognition is not extendable and does not in any way imply any obligation to recognize or affiliate the school beyond Class VIII.
2. The School shall abide by the provisions of Right of Children to free and Compulsory Education Act,2009(Annexure) and the Right of Children to Free and Compulsory Education Rules, 2011(Annexure II).
3. The Society /School shall not collect any capitation fee and subject the child or her parents.
4. The School shall not deny admission to any child's guardians to any screening procedure.
 - (i) For lack of age proof.
 - (ii) If such admission is sought subsequent to the extended period of ninety days for admission and on the ground of religion, caste or race, place of birth or any of them.
5. The School shall ensure that:-
 - (i) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in the school.
 - (ii) No child shall be subjected to physical Punishment or mental harassment.
 - (iii) No child is required to pass any Board examination till the completion of elementary education.
 - (iv) Every child completing elementary education is awarded a certificate as laid down under rule of the Right of Children to free and Compulsory Education Himachal Pradesh Rules, 2011
 - (v) Students with disabilities /special need are given admission as per provisions of the Act,
 - (vi) The teacher are recruited with minimum qualification as laid down under section 23(1) of the Act the current teachers who, at the commencement of his Act did not possess minimum qualification shall acquire such minimum qualification by march,2015.
 - (vii) The teacher performs his/her duties specified under section 24(1) of the Act.
 - (viii) The teacher shall not engage himself or herself for private teaching activities.

6. The school shall follow the syllabus on the basis of curriculum laid down by academic authority under sub-section (1) of section 29.
7. The school shall enrol students proportionate to the facilities available in the school specified in the section 19 of the Act.
8. The school shall maintain the standards and norm as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under:-

9. No. unrecognized classes shall run within the premises of the school or outside in the name of school.
10. The school building or other structures or the ground shall not be used during the day or night for commercial or residential purposes, except for the purpose of residence of any employee of the school or for political or non- education activity of any kind whatsoever.
11. The School shall be run by a society registered under the Societies Registration Act, 1860 (21 of 1860), or a public trust constituted under any law for the time being in force.
12. The School shall not be run for profit to any individual, group or association of individuals or any other persons.
13. The accounts of the school shall be audited and certified by a Chartered, Accountant and proper accounts statements shall be prepared as per rules. A copy each of the statements of Accounts shall be sent to the Deputy /Director /Block Elementary Education Officer every year.
14. The recognition Code Number allotted to your school is **EDN-BLS (RTE) ELE /2012/154** this may please be noted and quoted for any correspondence with this office.
15. The school shall furnish such reports and information as may be required by the Director of Education / of the State Government /local authority as may be issued to secure the continued fulfilment of the condition of recognition or the removal of deficiencies in working of the school.
16. Renewal of Registration of Society if any be ensured.
17. The state Government may specify additional conditions from time to time, for compliance.
